

## **Region X Oral Language Festival**

To Principals, Vice Principals, Resource Teachers, and Oral Language Festival Coaches:



Please make sure students are taken to the La Viña multipurpose room upon arrival and are chaperoned at all times. At the conclusion of judging, students will be released. Students may wait in the quad area, or sit in the La Viña Multipurpose Room as they wait for the awards ceremony to begin.

The first place winner/s from each category will advance to the Kern County Oral Language Festival on Saturday, April 26, 2025 at Stonecreek Junior High School in Bakersfield.

Each school may send 2 students/groups per category to the Region X Oral Language Festival. We will be using the KCSOS rules/judging criteria for the regional event. Enclosed you will find a copy of the guidelines for the competition. Please read and follow the guidelines carefully. The KCSOS will not allow students to participate in the county event if the guidelines are not followed.

All literature selections are required to be approved by the site principal. Literature selections need to be appropriate for age, event and presentation to a community audience which may include small children. Inappropriate selections will disqualify the student(s) from participating. Literature selections must be published works (in print) that can be found in the library or at school. Selections only available in regional newspapers, magazines, video/audio recordings, or on the Internet are not allowed. Selections must have an author (no anonymous pieces).

All Region X forms should be submitted e-mail or mail to Lea Cantu in Educational Services (contact information below). All forms should be typed. Forms may be accessed from the district website at <a href="https://www.duesd.org/Page/519">https://www.duesd.org/Page/519</a>.

Please submit the names of your site coaches on the attached Coach Form by <u>Thursday</u>, <u>January 17, 2025</u>. As in the past, <u>each participating school is required to supply three</u> helpers who will serve as judges and facilitators at the Region X Oral Language Festival. Their names must be submitted on the attached <u>Judge/Facilitator Form by Thursday</u>, <u>February 6, 2025</u>.

School events must be completed and Student Entry Forms submitted by Thursday, February 6, 2025.
